Closing Costs > Loan Estimate and Closing Disclosure Tabs

- ✓ Updated the calculation for the *Funds for Borrower* field to include costs from the *Transactions* screen > *B. Improvements, Renovations, and Repairs* field.
 - This update complies with Truth in Lending (Regulation Z) § 1026.37(h)(1)(v) and § 1026.38(j)(1)(ii), (iii), and (v).

AUS > LPA Tab


